

**TERMS AND CONDITIONS OF STANDARD PROBATION**

**PREBLE COUNTY JUVENILE COURT**

You have been placed on probation. During this time, you are to obey any and all special terms and conditions of probation as ordered by the juvenile court including each and all of the following conditions. Failure to do so may result in a probation violation complaint being filed with consequences including additional costs, fines, and/or detention time.

1. You are to obey all Federal, State, and Local Laws or Ordinances. Additionally, you shall advise the Probation Officer within 24 hours if you were arrested or cited for any offense, detained in any manner, or had any conversation with a Law Enforcement Officer during an investigation of a criminal or traffic offense.
2. You are to honestly and completely answer all questions asked of you by your parent(s) court-appointed Guardian Ad Litem, any Probation Officer and any law enforcement officer.
3. You shall obey the reasonable and proper directions of your parent(s) or court-approved custodians; they shall know and approve of your whereabouts at all times and the individuals that you are with.
4. You shall attend school regularly and obey all school rules. You are to notify your Probation Officer by 8:30 a.m. on any school day that you will miss for any reason, and you are to notify your Probation Officer before you leave school if you need to leave early for any reason. If you are home from school because of illness, you are not to leave your home that day or night except to keep a doctor's appointment. Should you be suspended or expelled, you will be required to attend suspension school. The parent(s)/guardian(s) will be required to transport to and from the suspension school.
5. You shall not possess, use, or consume mood altering chemicals or substances such as beer, liquor, drugs; marijuana, any synthetic drugs, or any tobacco products. You are not to be with anyone who possesses any alcohol or tobacco product, other than your parents. You are not to be with anyone who is illegally using any alcohol, tobacco product, intoxicants, illegal drugs and/or drug paraphernalia, nor frequent places where such substances are kept or sold.
6. You shall submit to random and/or periodic tests of your blood, breath, urine, or hair as directed by a Probation Officer. You are not to possess or use any substance and/or devices that would alter said tests.
7. You are to seek and maintain regular stable employment as directed by your Probation Officer.
8. You shall report to your Probation Officer at least once each calendar month. You shall meet at such times and places as directed by the Probation Officer and follow all directives of the Probation Officer.
9. You are only to live with your parent(s) or court-approved custodian(s). You shall report any change in address or phone number. You shall notify the Court before leaving the State of Ohio (excluding Wayne County, IN).
10. You shall not possess any weapon of any description including but not limited to firearms, knives, nunchucks, or martial arts weaponry, dangerous weapons, or contraband. You are not to possess any ammunition or weapon replicas. You are not to possess any dangerous animal. You are not to involve yourself in activities in which weapons are used, including but not limited to hunting or target shooting without prior permission of your Probation Officer. You are not to remain in any vehicle, dwelling, or building wherein anyone possesses a weapon, ammunition, weapon replica, or dangerous animal.
11. You shall consent to search and seizure of your person, property, automobile, residence, or any container under your control at any time by direction of the Probation Officer with reasonable cause without benefit of a search warrant.
12. Your friends are to be approved by your parent(s) or court-approved custodian(s), and Probation Officer. You shall not associate with any codefendants, gang members, probationers, any known criminals, or delinquents. This shall include phone, text, and social media.
13. You are to abide by all rules of any program or facility in which you are placed.
14. You are to carry valid picture identification at all times.
15. You will observe a curfew of \_\_\_\_\_ o'clock p.m. Sunday through Thursday and \_\_\_\_\_ o'clock p.m. on Friday & Saturday.
16. You shall not alter your appearance (Tattoos, Piercings, Hair Color) without prior approval of your parents and your probation officer.

I have personally read, understand, and agree to abide by all of the preceding Terms and Conditions of Standard Probation. I understand that my failure to comply with any or more of the above terms could cause my probation to be extended, any suspended disposition or costs imposed or may result in my arrest and holding in Detention (locked facility) and/or return to Court.
