ADULT TERMS AND CONDITIONS OF STANDARD PROBATION

PREBLE COUNTY JUVENILE COURT

You have been placed on probation. During this time, you are to obey any and all special terms and conditions of probation as ordered by the juvenile court including each and all of the following conditions. Failure to do so may result in a probation violation complaint being filed with consequences including additional costs, fines, and/or jail time.

1. You are to obey all Federal, State, and Local Laws or Ordinances. Additionally, you shall advise the Probation Officer within 24 hours if you were arrested or cited for any offense, detained in any manner, or had any conversation with a Law Enforcement Officer during an investigation of a criminal or traffic offense. You are to honestly and completely answer all questions asked of you by any Probation Officer and any law enforcement officer.
2. You shall cause any child/ children under your care to attend school regularly and obey all school rules. You are responsible to ensure that any child/children in your care maintain passing grades and complete all assignments. You are to notify your Probation Officer by 8:30 a.m. on any school day that the child will miss for any reason, and you are to notify your Probation Officer before the child leaves school if they need to leave early for any reason. If a child/children under your care are home from school because of illness, they are not to leave your home that day or night except to keep a doctor's appointment. Should any child/children under your care be suspended or expelled, you will be required to have them attend suspension school and are responsible to transport to and from the suspension school or any school detentions ordered. You shall adequately support any and all dependent persons of which you are responsible.
3. You shall not possess, use, or consume mood altering chemicals or substances such as beer, liquor, non-prescribed medication, drugs; marijuana, any or any synthetic drugs. You are not to be with anyone who is drinking alcohol, or using any illegal drugs and/or drug paraphernalia, nor frequent places where drinking and/or such substances are kept or sold.
4. You shall submit to random and/or periodic tests of your blood, breath, urine, or hair as directed by a Probation Officer. You are not to possess or use any substance and/or devices that would alter said tests.
5. You shall report to your Probation Officer at least once each calendar month. You shall meet at such times and places as directed by the Probation Officer and follow all directives of the Probation Officer. You shall permit the Probation Officer home visits.
6. You shall not change your address, move from the County, or leave the State of Ohio (excluding Wayne County, IN) without permission of the Probation Officer &/or this Court.
7. You shall not possess any weapon of any description including but not limited to firearms, knives, nunchucks, or martial arts weaponry, dangerous weapons, or contraband. You are not to possess any ammunition or weapon replicas. You are not to possess any dangerous animal. You are not to involve yourself in activities in which weapons are used, including but not limited to hunting or target shooting without prior permission of your Probation Officer. You are not to remain in any vehicle, dwelling, or building wherein anyone possesses a weapon, ammunition, weapon replica, or dangerous animal.
8. You shall consent to search and seizure of your person, property, automobile, residence, or any container under your control at any time by direction of the Probation Officer with reasonable cause without benefit of a search warrant.
9. You shall advise any changes in your employment, employment status or phone number within 24 hours.
10. You are to carry valid picture identification at all times. You shall not associate with anyone on probation or parole.

I have personally read, understand, and agree to abide by all of the preceding Adult Terms and Conditions of Standard Probation. I understand that my failure to comply with any or more of the above terms could cause my probation to be extended, any suspended disposition or costs imposed or may result in my arrest and holding in Jail (locked facility) and/or return to Court.
